Summary

This report advises Members of the current work programme and allows them to adjust it in the light of latest priorities, issues and circumstances and provides an opportunity to shape and direct the Committee's activities over the year.

- Budget and Policy Framework
- 1.1 Under Chapter 4 Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny committee has the responsibility for setting its own work programme.
- 2. Background
- 2.1 The Committee's rolling work programme for the 2021/22 municipal year is attached at Appendix 1. One of the Committee's functions is to provide guidance and leadership on the development and co-ordination of the scrutiny function for all Overview and Scrutiny Committees. Appendix 2 sets out the work programmes for the other Overview and Scrutiny Committees.
- 3. Agenda Planning Meeting
- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 28 October attended by the Chairman, Vice-Chairman and Opposition Spokesperson.
- 3.2 At the meeting, it was suggested that the report on the Council Tax Reduction Scheme for 2022/2023 be added to the work programme as an item for consideration at the 27 January meeting of the Committee, prior to its consideration at Cabinet on 8 February. The draft work programme at Appendix 1 has been amended accordingly for Members' approval.

- 3.3 Also at the agenda planning meeting, the Assistant Director, Legal and Governance raised the issue of the length of meetings and advised that he would work with officers to identify proposals for more manageable meetings which he would bring to Members in due course for a wider discussion.
- 3.4 Members will note that the Forward Plan lists all items that fall within the Committee's remit and that the list of topics to be scrutinised exceeds capacity. This means that items on the agenda have to be prioritised in order to manage the Committee's business, however despite current arrangements many meetings last until very late into the evening. This is unfair on Members who have to juggle the responsibilities of their office and other calls on their time e.g. employment, caring responsibilities. It also can create transport difficulties for both Members and officers commuting by public transport.
- 3.5 Members are recommended to carefully review future draft agendas balancing more detailed scrutiny but of fewer items. It is suggested that as a rule of thumb it should be assumed each substantive item will take approximately 30 minutes to consider, and thus an agenda should have no more than 4 or 5 substantive items, i.e. plan for a meeting to last between 2 ½ and 3 hours.
- 3.6 The draft work programme at Appendix 1 currently includes 6 substantive items for the meeting scheduled for 27 January 2022 and it is therefore recommended that the Medway Norse Update report be moved to the meeting scheduled for 31 March 2022.


4. Task Groups

- 4.1 At the last meeting of the Committee held on 21 October, following the discussion under the Climate Change Action Plan item, a Member suggested electric transport as a Task Group review topic. It was agreed that, at this meeting, Members would be updated on the agreed programme of Task Group reviews.
- 4.2 The Council has agreed that up to three in-depth scrutiny Task Groups or themed Overview and Scrutiny Committee meetings can be supported in total across all four of the Council's Overview and Scrutiny Committees every year, with each review running successively. The length of a review would be dependent on the pace the Task Group wished to take. A process for determining the programme of Task Group themes and activity has been agreed, with the Business Support Overview and Scrutiny Committee having a co-ordinating role. Topics are prioritised on a criteria selection basis reflecting best practice.
- 4.3 The current round of topics that has been agreed is as follows, although it was subsequently agreed that the second review be deferred to enable a review into early help and parenting support, given the improvement of children's social care became a corporate priority for the Council after it was judged inadequate in July 2019. This additional in-depth review took place and concluded earlier this year.

Topic
Review 1: The Voluntary Sector
Review 2: Physical Activity
Review 3: Town Centres
Review 4: Support for Carers

- 4.4 The next scheduled Task Group is therefore Physical Activity and officers have been doing some preliminary work in preparation for this. However, Business Support, along with the other O&S Committees, may wish to vary the topics given this schedule was agreed in 2019 and has been considerably delayed and disrupted by the Covid-19 pandemic and the Children's Services improvement journey.
- 4.5 Should any of the Committees wish to consider a new topic, then Members are asked to bear in mind that, when selecting topics for in-depth review, they should use the following tool as a way of selecting and prioritising a topic.
