## **WORK PROGRAMME**

# Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

- 1. Budget and policy framework
- 1.1. Under Chapter 4, Part 5 of the Constitution Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny Committee has the responsibility for setting its own work programme.
- 2. Background
- 2.1. Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.
- 3. Agenda planning meeting
- 3.1. Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 11 November 2021.
- 3.2. At the meeting, Members suggested the following:
  - 3.2.1. To defer the Kent and Medway Children and Young People Suicide Prevention Action Plan:
  - 3.2.2. Officers to look at scheduling an update on Medway's improvement journey, including the latest action plan and progress against that;
  - 3.2.3. Feotal Alcohol Syndrome and support services officers to provide this information via a briefing note/an information session via MS Teams.

- 3.3. Members also referred to the funding formula for mainstream schools and academies and the lack of opportunity to scrutinise or fully understand how the formula worked because of the tight timescales each year. Officers undertook to provide an information document for Members to set out the process for the formula, how it works and what factors determine certain aspects. Officers also offered to provide a further session at a later date to talk through this if Members felt it necessary.
- 3.4. After the meeting, officer suggested bring a report to the January meeting on the Local Transformation Plan for children and young people's emotional wellbeing and mental health. This has been reflected in the work programme attached at Appendix 1, subject to the Committee's agreement.

#### 5. Performance Data Workshops

- 5.1. At the Committee's meeting on 5 March 2020, it agreed a number of measures to maximise its involvement and impact in relation to the scrutiny of children's social care.
- 5.2. Part of those measures included the provision of detailed performance data to all members of the Committee on a monthly basis and for performance data workshops to be provided, in between Committees. The purpose of this is to strengthen the capacity for effective scrutiny of performance by providing an informal setting in which detailed analysis of the data can be undertaken. Members can then apply their increased knowledge and understanding to carry out an effective scrutinising role in main committee meetings and in task group activity.
- 5.3. The latest workshop was held virtually on 1 Septemb2 Novemberer 2021. This session was attended by the Assistant Director, Children's Social Care, the Head of Service for Early Help and Targeted Services and the Independent Scrutineer of the Medway Safeguarding Children Partnership who was also the Independent Chair of the Improvement Board.
- 5.4. The session focussed on missing children and talked Members through how the Council responds to incidents of missing children including those Medway children who are placed in care out of area, the prevalence of missing children incidents, partnership working involved and the focus and action needed.

## 6. Teacher representative

- 6.1 The position on the committee for a Medway teacher became vacant when Geoffrey Matthews moved jobs to a school outside of Medway.
- 6.2. Expressions of interest were invited and sent to all Medway schools with a closing date of Friday 19 November 2021. Democratic Services received a total of 5 expressions of interest.
- 6.3. As there have been more expressions of interest than vacant positions the Director People will consider each of these against the criteria attached at

Appendix 2, as agreed by this Committee in December 2015 and this will be done in consultation with the Chairman, Vice-Chairman and Opposition Spokesperson before bringing forward a recommendation for appointment to the Committee for consideration.

## 7. Implications for looked after children

- 7.1. Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for looked after children and have the same high expectations of them as they would for their own child, grandchild or niece/ nephew.
- 8. Financial and legal implications
- 8.1. There are no financial or legal implications arising from this report.
