### Summary

This report advises Members of the current work programme for discussion in the light of latest priorities, issues and circumstances, giving Members the opportunity to shape and direct the Committee's activities.

#### 1. Budget and policy framework

1.1 Under Chapter 4 – Rules, Part 4 paragraph 21.1 (xv) General Terms of Reference, each overview and scrutiny committee has the responsibility for setting its own work programme.

#### 2. Agenda planning meeting

2.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. An agenda planning meeting was held on 15 December, where the following changes to the work programme were recommended:

- *South East Coast Ambulance Service update* – move from January to March meeting
- *Healthy Pregnancy in Medway* - move from January to March meeting
- *Adult Neurodevelopmental Pathway (Autism and ADHD)* – add to work programme for March meeting

- 2.2 After the agenda planning meeting it was decided that the Annual Public Health Report (originally scheduled to come to this meeting) would now be submitted to the 2 April Cabinet meeting. Therefore, it is recommended that this is considered at the March meeting.
- 2.3 Appendix 1 to this report sets out the Committee's recommended work programme, taking account of the recommendations made at the agenda planning meeting.
