ORDER OF PROCEEDINGS AT THE CASE APPEALS HEARING

- 1. The clerk will introduce the appellant and the local education authority's representative.
- 2. The chair will introduce the members of the committee.
- 3. The proposed order of the proceedings will be as follows:-
 - (a) The case for the authority will be presented by the representative of the education department;
 - (b) The education department's representative may be questioned by the appellant and committee;
 - (c) The appellant or his/her representative may present their case;
 - (d) The appellant may be questioned by the education representative and committee members;
 - (e) The education department's representative may sum up;
 - (f) The appellant may sum up.

The committee members may ask questions at any time during the hearing if they require clarification of what is being said or if they need more information in order to reach their decisions.

In conclusion, the chair will inform all parties that the committee are required to consider the evidence and reach a decision in private and that the clerk to the appeal will notify the appellant and the education department of the decision within three working days of the hearing.

1. Budget and policy framework

- 1.1 The setting of policy relating to school transport is the responsibility of the Cabinet. The remit of this Committee is to determine appeals relating to the application of the Council's policy for assisting with transport for pupils and students at schools and colleges.
- 1.2 All decisions of the Committee should be made on the basis of evidence produced by the appellant or the local authority a decision may be subject to challenge if there is no evidence available on which the Committee could reasonably have formed its view.
- 1.3 The Council's Education Travel Assistance Policy must be given significant weight in determining appeals, so that the Council's discretionary powers can be exercised with proper consistency. However, the Committee must be prepared to consider making an exception to the general policy if the circumstances of the case justifies different treatment.

- 1.4 The Committee should avoid taking decisions which are inconsistent with Council policy unless there are adequate and relevant grounds for doing so. All decisions should be made on the basis of evidence produced by the appellant or the local authority a decision may be unlawful if there is no evidence available on which the committee could reasonably have formed that view. Each party to the hearing (the appellant and the authority) should be given the opportunity to hear and answer evidence. Where matters are raised by a party for the first time at the hearing itself, the other party must be given opportunity to respond.
- 1.5 The Committee must give reasons for the decision that it has made
- 2. Background
- 2.1 Legislation
- 2.1.1 Under Section 444 of the Education Act (1996), parents have a duty to secure regular attendance of registered pupils at school. Under the requirements of this Section, together with Section 509, Local Education Authorities are obliged to make arrangements for the provision of free transport to the nearest qualifying school for children aged under eight, at the beginning of the school term, for whom the home to school journey is more than two miles, and for children aged 8 and above for whom the journey to the nearest qualifying school is more than three miles.
- 2.1.2 Children aged 11 years or older from low income families will also qualify if they live more than two miles but not more than six miles from one of their three nearest qualifying schools. Low income families are defined as where children are entitled to free school meals or where their parents receive the maximum level of Working Tax Credit.
- 2.1.3 The Act says that the measurement of the qualifying distance must be along the "nearest available route". The Act does not define what constitutes the "nearest available route" but, where the definition of the route has been an issue, the Courts have decided that the route must be one along which a child, accompanied as necessary, can walk with reasonable safety. The route does not fail to qualify as available due to dangers, which may arise if the child remained unaccompanied. Regard has to be given to (amongst other things) the age of the child and to the nature of the route or alternative routes, which the child could reasonably be expected to take.
- 2.2 Medway's Education Travel Assistance Policy
- 2.2.1 The definition of home address is:
 - The address that must be used for the assessment of eligibility for home to school transport is the child's main place of residence.
 - If the child is from a separated family and may live part time with each parent at two addresses, only the child's main place of residence can be

considered for home to school transport purposes and where the child spends the majority of the school nights.

2.2.2 The definition of the nearest qualifying school is:

- The geographically nearest school to the pupil's home address that is suitable to the pupil's age, ability and aptitude. For secondary school age pupils, Medway Council also take into account whether a child is selective (grammar) ability or non-selective (non-grammar) ability.
- Only one school can be deemed as the nearest qualifying school and this can include non-Medway schools.
- A parent's preference for a single sex, mixed or particular type of school or preference for a school because of its specialism or because it teaches certain subjects cannot be taken into account.
- A Medway grammar school will be considered as the nearest qualifying school for a child who has been deemed to be of selective ability under the Medway Test assessment procedures. This also includes The Howard School due to its Bi-lateral status.
- 2.2.3 If a child attends a school for faith reasons, we will count this as your nearest qualifying school and will provide free home to school transport if:
 - Your child is a regularly practicing member of a church of the same faith as the school. Proof of faith/denomination will be required and the application form signed by the appropriate church authority, if such verification is not provided, the application cannot be considered on denominational grounds.
 - They live at least 2 miles from the school if they are under 8-years-old or at least 3 miles from the school if they are 8 or older.

2.2.4 How walking routes and distances are measured:

- The distance calculated for home to school transport purposes will be measured from the pupil's home address to the school address using the shortest available walking route.
- Distances are calculated using the Medway geographical information software and may take account of footpaths, public rights of way, etc.
- The shortest available walking route is one along which a child can walk to school, accompanied as necessary, with reasonable safety.
- The safety of a route is considered and the relevant route safety assessment focuses primarily on identifying the road safety risks observed along the route. Such assessments are handled in accordance with the national 'Assessment of Walked Routes to School' guidelines produced by Road Safety Great Britain in 2012 which state 'Case law has found that assessments must look at the relationship between pedestrians and traffic only. Personal safety issues of children traveling alone are not considered. Local authorities are not legally obliged to provide free transport just because parents perceive the route to be unsafe on the grounds of personal safety and security.

 The same method of measurement calculation is used for all applications to ensure that the nearest qualifying school can be identified. If the route calculated is determined to be unavailable, then the distance and route is used for measurement purposes only and there is no expectation for the child to walk the route determined

3. Background to the Case

- 3.1 On 10th December 2022, Ms A Faleye applied for free home to school travel assistance for her daughter Ayomide Soetan. (Appendix 1)
- 3.2 The School Admissions and Transport team wrote to Ms Faleye (Appendix 2) to explain Ayomide does not qualify for free home to school transport under the standard criteria. However, Ayomide may qualify under the low-income criteria if Ms Faleye can evidence she is in receipt of a qualifying benefit.
- 3.3 On 13th January 2022, Clare Foreman, the family's Senior Early Help Worker emailed the School Admissions and Transport team (Appendix 3) requesting the decision to be reviewed with the following reasons:
 - Both of Ms Faleye daughters were subject to bullying at their previous school St John Fisher. Therefore, the family took the decision to move to Walderslade Girls' School.
 - The Walderslade Girls' School is much further and they will need to catch two busses.
 - Ms Faleye is a single parent, she works and is unable to apply for free home to school travel assistance under low-income. However, has limited funds to support paid transport.
 - The school is just under 3 miles from the home address and a 1 hour 10 minute walk.
- 3.4 The School Services Transport Manager did not uphold the stage one appeal (Appendix 4) with the following reasons:
 - The distance between your home address and the school has been measured below the minimum statutory walking distance of 3 miles.
 - From the photos provided, The School Services Transport Manager has been unable to verify that Ms Faleye has an annual net earned income of no more than £7400, as assessed by earrnings from up to three of the most recent assessment periods.
 - For the School Services Transport Manager to fully assess the lowincome element of the application, they have requested Ms Faleye download and print, or email a full copy of Universale Credit Statements for the last 3 assessment periods.
- 3.5 The School Admissions and Transport team received an email from Clare Foreman (Appendix 5) providing further contextual information. The information was considered by the School Services Transport Manager. However, the decision was not overturned.

- 3.6 Ms Faleye has requested (Appendix 6) that members consider an appeal with the following reasons:
 - Ms Faleye explains some of her outgoing payments are spent on her parents and braiding hairs for both daughters.
 - Ms Faleye is ill and currently unable to work full time, last year Ms Faleye reduced her hours to part time.

4. Risk management

4.1 The Committee has a responsibility to have regard to the Council's Education Travel Assistance Policy and other relevant evidence produced by the parties when considering appeals for school transport assistance.

Risk	Description	Action to avoid or mitigate risk
Consideration of appeals for financial assistance for the cost of home to school transport.	The Council has agreed a policy for the granting of home to school transport. Such policy is administered within the Children and Adult's Directorate. Parents can appeal to the School Transport and Curriculum Appeals Committee against an Officer's decision to refuse home to school transport assistance. In considering such appeals, the School Transport and Curriculum Appeals Committee must have regard to the Council's policy and other relevant evidence produced by the parties. Failure to do so could result in a challenge to the decision of the Committee.	Clear advice to members of the School Transport and Curriculum Appeals Committee of the circumstances under which the Committee may uphold appeals.

5. Financial implications

- 5.1 The cost of providing travel assistance via public transport (bus) to Walderslade Girls' School would be £659 per annum. A minimum estimate of total costs during the period of compulsory education would be £3,295.
- 6. Legal implications

- 7. Recommendation
- 7.1 Members are asked to decide whether travel assistance should be provided.

Transport applications for Khadijat Isiaka 10-Aug-2009 Year 8 and Ayomide Soetan 30-Jul-2007 Year 10 attending Walderslade Girls' School

Thank you for your email of 14th January 2022, providing your payslips and photos of your Universal Credit Statements. I am also in receipt of an email dated 10th January 2022 from Clare Foreman, Senior Early Help Worker, requesting that the decision to refuse home to school transport assistance for Khadijat and Ayomide be reviewed.

The Council's policy (which can be found at www.medway.gov.uk/gettingtoschool) states that transport assistance is normally only granted when a child meets one of the following eligibility criteria:

Standard Criteria	Where the school being attended is the nearest suitable school, meaning the nearest qualifying school to the home address with places available that provides education appropriate to the age, ability and aptitude of the child, and is over the minimum statutory walking distance* from the home address using the shortest available walking route.
Low-income Criteria	 Where the school being attended is one of the three nearest suitable schools, meaning the nearest qualifying schools to the home address with places available that provides education appropriate to the age, ability and aptitude of the child, between two and six miles from the home address, using the shortest available walking route. To qualify the parent/carer is in receipt of one or more of the benefits that would qualify a child for free school meals. These are Income Support Universal Credit (provided you have an annual net earned income of no more than £7400, as assessed by earnings from up to three of your most recent assessment periods) Income-based Jobseeker's Allowance Income-related Employment and Support Allowance The guaranteed element of State Pension Credit Support under Part VI of the Immigration and Asylum Act 1999 Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190) Or Where a family is in receipt of the maximum level of Working Tax Credit (WTC).

^{*}The minimum statutory walking distance by the shortest available walking route are:

- For a child under eight years of age and low-income families two miles
- For a child aged eight and over three miles

All distances calculated for home to school transport purposes are measured using the shortest available walking route from the home address to the school address.

Distances are calculated using the Medway geographical information software and may take account of footpaths, public rights of way, etc. The shortest available walking route is one along which a child can walk to school, accompanied as necessary, with reasonable safety.

I have investigated your case and note that the distance between your home address and Walderslade Girls' School has been measured below the minimum statutory walking distance of 3 miles.

As indicated in our decision letter in respect of Ayomide, she will only qualify for transport under the low-income criteria, if you can evidence that you are in receipt of one of the low-income benefits outlined overleaf. This is because Walderslade Girls' School is not her nearest suitable school with a place available, but is one of her 3 nearest suitable schools. Additionally, the distance between your home address and the school has been measured below the minimum statutory walking distance of 3 miles.

Our decision letter in respect of Khadijat stated that she would not qualify for home to school transport under the standard or low-income criteria because there are three schools that have been measured closer to your home address.

As part of my review, I have considered whether any closer schools could have offered her a place. Once the closer schools that do not have a place in year 8 have been discounted from our assessment, Walderslade Girls' School is one of Khadijat's 3 nearest suitable schools. This means that as in Ayomide's case, she will only qualify for transport under the low-income criteria, if you can evidence that you are in receipt of one of the low-income benefits outlined overleaf.

I have reviewed the documents that you have provided in respect of low-income. Regrettably, payslips do not provide us with the information required to confirm that you are in receipt of one of the qualifying low-income benefits. I have tried to establish whether Ayomide and Khadijat are in receipt of free school meals, and using the sources available to me, I have been unable to confirm that they qualify.

I understand that you are in receipt of Universal Credit. However, from the photos that you have provided, I have been unable to verify that you have an annual net earned income of no more than £7400, as assessed by earnings from up to three of your most recent assessment periods. Please download and print, or attach to an email, a full copy of your Universal Credit Statements for the last 3 assessment periods, in order that we can fully assess this element of your application.

I am sorry to learn that Ayomide and Khadijat have experienced bullying. Whilst I empathise and understand that the decision was taken to move them to an alternative school because of this, the qualifying criteria for free home to school transport is clear, and it cannot be provided on this basis.

Having reviewed your case noting all of your comments and based on the information currently available I can confirm that the decision not to offer transport assistance for Ayomide and Khadijat is correct and in accordance with the Council's policy.

You may make a formal Stage 2 appeal to Members of Medway Council against this decision if you wish, and I enclose further information about this process, together with an appeal form. If you decide to submit a formal appeal, please complete the form and return it to me within 20 working days from the date of this letter. You will see from the enclosed information that you may seek representation at the appeal from one of your local councillors. The councillors for your ward are:

Before making a formal appeal to Members of Medway Council, I would like to notify you of the Medway Youth Pass, which entitles all young people who live in Medway to pay half the adult fare at all times when travelling on any local bus service, up to the end of the academic year after their 18th birthday. To qualify, the bus journey must start in Medway and can be to any destination in Medway or Kent (as long as any changes of bus are in Medway). The pass will be valid for three academic years (including the academic year your child is currently in) or until the end of Year 11, whichever is sooner. You can apply for a 16-18 pass as soon as your child turns 16 years old.

Application forms are available from all Medway schools, Strood, Rochester, Chatham and Gillingham libraries, and the Council offices at Gun Wharf and the Council Contact points.

Thank you for your email, and the additional information that you have provided.

I understand the reasons that Ms Faleye decided to move her daughters to another school, and have considered this as part of my review. Whilst I empathise, this information does not change the decision not to offer transport.

Even if Walderslade Girls' School were considered Kadijat and Ayomide's nearest suitable school, the distance between their home address and the school is below the minimum statutory walking distance of 3 miles to qualify under the standard criteria. Both girls will qualify for transport under the low-income if the parent can evidence that she is in receipt of one of the qualifying benefits as outlined in my letter. To clarify, the requested proof of benefit can be submitted for assessment without the case going to appeal.

Ms Faleye does also have the option to appeal to Members, who will consider the case and whether the policy has been correctly applied, and where it has, if any exceptional circumstances justify a departure from the policy.

Good morning Laura, School Services Transport Manager, and Councillor Murray,

Reference 1029125/1029572 – Declined Transport Applications for Khadijat Isaika and Ayomide Soetan – attending Walderslade Girls School.

Thank you Laura for copying me into the response and further appeal process for this family, I have read and fully understand that the criteria has not been met.

By further appeal on the Low-Income Criteria – the family will still be above threshold.

Abigail received the letter and was disappointed at the appeal decision, saying that she will 'just give up', however, I asked her to continue the appeal process as I believe that she has acted in the best possible way to safeguard and

manage her situation to bring about the best possible outcome for her daughters; I would like to share this with you, although I fully understand that there is a criteria that needs to be met.

As Family Solutions – Early Help, we see the bigger picture – the holistic view – the impact on the children – rather than the facts and figures as shown and completely agree that the application for Free School Transport does not meet criteria – which is why I am writing this email – rather than supporting Abigail to complete the second appeal form – based entirely on her income.

Abigail has consented to Early help and therefore consents to share with professional supporting the family. So I will discuss the original referral to MASH – outcoming in allocation to Family Solutions in September 2021 on the girls return to school following the Summer Holidays.

Ayomide – now aged 14 now, is known as Rebecca. Rebecca had a relationship with a young male who attended St John Fisher – this relationship started during the first lockdown – over social media.

After the initial lockdown and return to school/bubbles in 2020 and 2021 – and following the second, longer lockdown, the relationship developed in to what can be described as unhealthy.

The relationship was abusive, controlling, sexual, obsessive, and violent - the incident that prompted the referral was an incident of abuse that left Rebecca needing to attend A&E following a 'fight at school'.

School safeguarding, police and Mum were all involved, and Rebecca's safety was managed – but the episode resulted in her having a lot of problems at school and at home; other pupils were being reactive to the drama and rumours passed around the school about her. This fed into Year 8 – and Khadijat – known as Ayo – defending her sister – also became involved in fighting. In a head to head with Mum – Rebecca walked out of her home late at night and eas returned safely by police – but the pattern of behaviours was concerning.

There has been intensive work with Rebecca, Ayo and Mum from Family Solutions; reparation was attempted at St John Fisher – however – with the other young person still attending the school – this was still a 'source of interest' and Rebecca was unable to heal and move on.

Abigail decided Walderslade Girls (an all girls school was a preference) and I fully supported this application An application was also made to Brompton Academy – which was declined. In fact – WGS was the only school that agreed to accept both girls' in term application.

Both have settled well, both have made new friendships and Rebecca is achieving again.

I believe that Abigail made the right choice.

Abigail works part time – and has some physical health problems, which she is having treatment for and DWP are currently supporting her with PIP. Her income and expenditure have been reviewed – she is able to provide for her family within a strict budget. Abigail is a single mother and father to the children, Ade lives in London, fully supports her and the three children – however – he is also supporting his other family in Nigeria, and cannot add to the child maintenance that he pays for Ayomide, Khadijat and Adenji.

Due to Mums work hours – the girls have to collect their 7 year old brother from school (St Michaels)

Please can you consider this appeal as 'close to the expenditure limits', and reconsider the decline to support with Free School Transport?


