Baba Food and Wine operate as a supermarket and convenience store authorised to sell alcohol for consumption off the premises 24 hours a day. The Designated Premises Supervisor is Mr Alaittin TEMUR and the Premises Licence Holder is TEM-AS Kent Limited. Companies house shows TEM-AS Kent Limited with company directors being Mr Alaittin TEMUR and Aliseydi ASLAN.

The premises is located in the High Street at Gillingham, a busy town centre location surrounded by a variety of business, retail and residential properties. Gillingham High Street and the immediate surrounding area suffers high levels of crime, disorder and antisocial behaviour. The area is covered by both a public space protection order (PSPO) and cumulative impact policy (CIP). Currently the High Street is suffering high and unacceptable levels of persons regularly found to be street drinking and consuming alcohol within the PSPO and CIP. Persons found to be street drinking are often persons that are alcohol dependent consuming high strength beers and ciders. An inevitable consequence of street drinking could be aggression, public nuisance, public urination, alcohol related litter and crime and disorder.

In recent weeks it has become increasingly evident to both the town centre policing team and police licensing officers that street drinking levels in Gillingham appear to be increasing, with the area directly outside of and next to this premises being of particular concern. Kent Police will evidence multiple occasions whereby in recent weeks this premises have sold alcohol to street drinkers. Evidence provided is by police officer statement, CCTV evidence, Police officer body worn camera or both. Kent Police will provide evidence for the following dates and times:

#### Saturday 1st January 2022

Approximately 01:00 a police patrol observed a male sat on the bench directly outside St Marks Church on High Street consuming what appeared to be a can of lager or cider. (St Marks Church is the immediate neighbouring property to Baba Food and Wine). Sat on the ground directly outside of the premises surrounded by her bedding and belongings was a female that appeared to be homeless. A male went into the premises and purchased a bottle of cider. Upon exiting the premises, the male engaged in conversation with the female and she then produced an empty wine glass. The male proceeded to fill the wine glass with the cider which the female consumed in the street. Staff were challenged by police.

#### Tuesday 1st February 2022

Approximately 11:00 a male purchased 2 cans of what is suspected to be high strength lager or cider. This same male consumed the alcohol in the street outside until approximately 11:22.

#### Tuesday 1st February 2022

Approximately 16:39 a male purchased 2 cans of what is suspected to be high strength lager or cider. The male then sat on a bench outside St Marks church and consumed the alcohol leaving the area at approximately 16:56 seemingly leaving an empty beer can discarded on the bench.

#### Thursday 3rd February 2022

Approximately 09:16 a male purchased a single can of HCC cider. At approximately 09:20 another male was supplied with a can of Stella lager. Both males were spoken to at approximately 09:42 by town centre officers outside of St Marks Church. The items purchased by the males at the premises had been consumed in the street.

#### Thursday 3rd February 2022

Approximately 16:12 a male purchased what appears to be 2 cans of lager or cider at the premises. This same male consumed alcohol in the street whilst stood outside of St Marks Church.

#### Saturday 5th February 2022

Approximately 05:37 the premises called police and reported a drunk male fighting with other customers outside the premises. The drunk customer also caused damage to shop furniture and had reportedly been causing issues for a period of around 2 hours. This male was subsequently arrested by police for multiple

offences including assault of an emergency worker (police officer). Police will evidence that the premises sold alcohol to this male prior to police attendance.

#### Thursday 17th February 2022

Approximately 08:39 a police patrol observed 2 males of dishevelled appearance walking along High Street in the direction of the premises. One male was seen to sit on the bench directly outside of St Marks Church whilst the other went into the premises. The male purchased a large bottle of Frosty Jack cider and upon leaving the shop joined the male sat on the bench where they remained consuming the cider in the street, sharing the bottle between them. This matter was addressed with the DPS.

#### Saturday 19th February 2022

Approximately 11:46 a male purchased a bottle of beer and a can of lager from the premises and then consumed the alcohol with another male whilst sat on a bench outside of St Marks Church. These persons were directed to leave the area by town centre PCSO at approximately 12:01.

#### Friday 25th February 2022

Approximately 11:00 police were in attendance at the premises conducting CCTV enquiries. At this time the same male from 17th February 2022 attended the store and purchased a bottle of cider. Shortly after the male was seen by police to be sat on a bench opposite the premises drinking the cider. Staff were challenged by police.

Prior to submitting this full premises licence review application, Kent Police have taken a considered and stepped approach, engaging with staff and the DPS to explain our concerns and offer advice and guidance. The premises currently sell a vast selection of high strength beers and ciders that are often considered favourable amongst street drinkers. In conversation with Kent Police, the DPS and his partner have offered to remove a small selection of high strength products from sale, but not with immediate effect proposing only to do so once all stock of that particular product has sold out. The premises are not prepared to remove all high strength beers and ciders from sale and wish to continue to sell a large quantity of such products for what would appear to be a pure monetary gain. The DPS and staff appear dismissive of the issues caused by street drinkers and when challenged have excused their actions by referring to the street drinker in question being "a good guy" or suggesting "he is okay" (words to that effect).

The fact that the premises continue to sell alcohol to street drinkers shows that our advice and concerns are not been considered or taken onboard. The fact that the premises continue to sell alcohol to street drinkers and to intoxicated persons shows that the premises staff, the DPS and the PLH have a blatant disregard to both the promotion of the licensing objectives and to the licensing act and have little regard to either the CIP or the PSPO or to the issues that are affecting the residents in the immediate area.

The sales of alcohol evidenced above are being consumed by street drinkers in the immediate area directly outside of St Marks Church and outside of the premises from where the alcohol is being purchased. The street drinking is blatant and not hidden leaving Kent Police to believe that the premises must have knowledge of the fact and must know that they are contributing to and fuelling street drinking. The sales of alcohol evidenced above are incidents of which Kent Police have been made aware or identified. On the balance of probabilities there are likely many other incidents that have not come to police attention.

Kent Police have considered all options available and have no faith or trust in Mr Temur or his staff moving forward.

Kent Police seek revocation of the premises licence. Should revocation not be considered then Kent Police would seek the addition of the following premises licence conditions:

- 1- Reduction in licensable hours to 09:00 to 20:00.
- 2- No beer, lager, cider or spirit mixer above 5.5% ABV to be supplied.
- 3- No single sales of beer, lager or cider. Only purchase of 4 or more items will be permitted.
- 4- Outside the hours authorised for the sale of alcohol, all alcohol within the trading area is to be secured behind locked grilles, screens or cabinet doors.
