Evening,

I have recently read in the newspaper over the concerns or the casino rooms nightclub in Rochester and the need to review the liscence.

This follows other newspaper articles I have read over the way staff have behaved etc and after seeing so many negative comments from people who openly admit they have never been, I felt I had to just pass my comment... the club does not seem to be getting fair representation.

I am 35 years old and I am still sadly an avid clubber, I have been going to the casino rooms for many years since I was 18. We aren't just talking every now and again a couple of times a year ... we are talking weekly and sometimes even multiple times a week.

So I have alot of experience with the venue to be able to pass an honest judgement. As I say I am 35, and a respectable lady who is a director of a very successful local company, maybe not the demographic you would expext to find there... I am not a youngster who just wants to go out and get drunk, whether it be a park bench or a club...I care about where I go out and would never frequent anywhere that made me feel unsafe or always seems to be trouble.

In my many visits I can confirm I have had nothing but positive experiences.

I myself had a bit of bother with a guy one evening, the bar staff alerted the bouncers and he was removed from the venue. He waited around outside after the night and the bouncer saw that I got in a taxi safe and that the guy in question got no where near me.

One night I drove and had to park at the other end of the highsteet, esplanade end. I left on my own but my anxiety kicked in and I didn't want to walk to my car on my own. The bouncers got me a drink and told me to wait and at the end of the shift escorted me to my car.

I have had lady 3 friends who have got themselves into a drunken mess...the newspaper articles suggested that when this had happened to them they were dismissed and kicked out, I can say this was not the case all 3 of my friends were taken to the medical room (which was in the downstairs room by the fire escape) and were all looked after and stayed there until they felt they were fit to get home or collections had been arranged. The bouncers ensured they got in their cab or lift safely.

Even a guy friend got in a terrible state and had vomited down himself, even he was treated in the club and allowed to rest before helping him make his way home. So its not just the girls who get special treatment. Everyone is treated equal.

I once found a guy drunk outside the club a little way up towards the high street, the bouncers still helped me get him help and we managed to contact his parents from his phone and called an ambulance. He was not the clubs responsibility but they helped.

.they cared.

I have seen more fights walking down the High Street with people coming out of other venues then I have seen in casino. In the very few instances I have seen trouble in the club it has been dealt with quickly and fairly, I have never seen anything underhand or aggressive from the staff. They handled the difficult situation well and calmly.

The whole team are friendly, welcoming, approachable and helpful. There are no issues with the clientel ... apart from they make me feel old!! They are there to have a good time.

I have seen groups of rowdy/aggressive lads get turned away, the club monitors who they let in.

My younger cousins go to the club, I have no issue...if my niece or nephew would want to go I would encourage it because it's a safe and controlled environment.

The staff do a great job, it's challenging...anything is with alot of people and alcohol but they do a great job.

My bag is always checked and even my ID despite my age, guess I should take that as a compliment.

I really don't have a bad word to say, but it would be a big loss if anything were to happen to the venue, its been going strong for many years and gives jobs to many staff who in a time where many hospitality venues didn't make it through the pandemic they need those jobs. I think it would have a knock on effect of the bars in the high street as alot of people do the rochester bar crawl before ending the night in the club... take away the club and you take away alot of those people who will have no choice but to go to Maidstone. Cab drivers, high street bars, the late night take aways will all suffer.

I am a local Medway Hackney driver and ply from the rank outside the club. The violence has gone down in my opinion to what it was 5 years ago.

I have only come across 1 young lady who seemed to have had been unwell through drugs. Here friends said she took a pill, and had a reaction.

I ended up taking her to Medway hospital, as she just stared into space. I handed her over to 2 ambulance drivers who took her inside. I was contacted by her a few days later, she thanked me, and said her drink must have been spiked.

But her friends said otherwise.

Could it be the case that people experiment with drugs, when it goes wrong to save face, they say my drink was spiked.

It might be beneficial to raise their entry age to 21 years old., supply a medical room to assess if they are drunk or drugged. Train door staff on how to recognise someone feeling unwell. Have a membership entry scheme (free to join)

Insure that the customers have not had too much alcohol before being let in. Ban manbags and handbags.

You listen to passengers say we loaded up on booze before we came out to save money.

People might have taken drugs before entering the club or any other bar, but become ill in there.

With out evidence an appeal would be mounted, as its only hearsay and conjecture.

Put a range of measures in place to discourage people spiking or taking drugs into the club. Make the club hire a drug dog the nights the club is open, checking customers and staff.

Getting in in December/January was a pain - queue with staff insisting on Covid passes, queue with doorstaff demanding for the stamp from the Covid passes IDs, queue for the search, queue to pay. I mean, it was annoying but I get that this had to be done so that we'd feel safe inside which my friends and I did. Every time I came, I saw the staff (bar, managers and security) being switched on and approaching customers to check if everything was Ok if they see something happen. I asked for a tissue once as had an existing wound open up and got asked if I needed first aid attention, I said no so they gave me tissue and a plaster. My female friends always ask for the stickers for glasses or the little plastic inserts for bottles and they're readily available. The bar staff are always friendly, despite the pressure of the job (I know I used to do it when I was younger) Door staff are alright, not as cheery but I've never had issues with them, even have a bit of a chat. I'm sure they go beyond what they're meant to and go out to high street and carpark to prevent chaos when they see an issue. For what it is, Casinos is one of the best places to party really with the staff doing their due diligence in their jobs.

To whom it may concern

I wished to write to you on a personal basis (and not in my professional capacity) to make representations on behalf of Casino Rooms nightclub in Rochester town centre in Medway and the conditions which are being proposed to be added to their license which have come to my attention.

As a resident of Medway for many years, I have frequented Casino Rooms nightclub on many occasions and have had nothing but positive experiences. I am a bit older now (43) but still feel safe and comfortable visiting. In fact I visited recently with a group of friends for a 40th birthday (with guests ranging in age from 18 to 70+) and received the very best service. The security staff are polite and knowledgeable – every member of our party was required to show ID and be subject to a search upon entering; one of the younger members had too much to drink and was refused service at the bar. In fact next weekend my wife and I will be taking our nephew and his girlfriend there to celebrate his 20th birthday. I am at an age where my friends children now go to the nightclub and without exception the feedback is positive.

During regular visits over the last 10-15 years, I have not witnessed any trouble and have always felt safe and secure within the venue. The club seems incredibly well run and as someone who has worked in the hospitality industry for 25 years (restaurants and nightclubs in Central London in my younger days, now hotels) they clearly make every effort to comply with all statutory and reasonable requirements to operate a safe and enjoyable venue. Yes of course from time to time I have witnessed patrons who have had too much to drink (rest assured this happens across the country an all venues that sell alcohol, even 5* hotels!) but my view is that such people are well treated and looked after by the venue and service is stopped when it is cleat an individual has had too much.

It seems unnecessary to me to target a venue which has such rich history in the area and has been operating well and safely for decades – unlike so many others I have visited in the area who appear to take little responsibility for themselves and their licence conditions. The panel should take into account recent global events as well – the whole country was in a state of lockdown limbo for almost 2 years and it is only natural that certain individuals are going to extremes to release 24 months of frustration at not being able to socialise. Pre-Covid my understanding is that the venue operated extremely well and in close partnership with the council and the police, so it now seems heavy-handed and unfair not to take that historic positive relationship into account and to punish them for the antisocial behaviour of a very small minority of patrons. In my view every reasonable effort is made daily to ensure a safe and secure environment for people to meet their friends but no hospitality venue can legislate fully for every eventuality – and this should be the key factor in any decision, that all possible measures are in place and regularly reviewed and updated, which seems to be the case.

Simply put my own experience is that it is a very well run venue that operates in a very challenging space; I do not see what more could be reasonably expected of them (from what I have seen myself). People who intend to cause trouble and/or drink too much will find a way to do so regardless of where, and the police's time and the council's time would be better spent working with (rather than against) late night venues to create positive experiences for patrons and build lasting relationships to protect the vast majority who simply want to have a good time, in a secure environment and get home safely; and to work *with* venues to lawfully deal with those few who do not, rather than shift the blame. The alternative of course is for people to spill into the streets after locals pubs and bars shut and create havoc in public areas, in my view the nightclub fulfils a public service in many ways and keeps people from drinking in the streets.

Please do not punish honest professionals who do their best and abide by the law because of a handful of troublemakers, especially when the hospitality industry in this country has been decimated by months of Covid related restrictions. As an industry we have borne the brunt of Covid and now it is a time for the authorities to work alongside the industry to safely remain open – my experience is that Casino Rooms is a safe venue, more so than many around it.

Please note again that this is a personal representation but feel free to contact me if further information is required. I trust that, as a loyal patron and admirer of Casino Rooms and what they do, that reason will prevail in this instance and not a kneejerk reaction to a very few unfortunate (and potentially unavoidable) incidents which the venue has taken all reasonable steps to mitigate against.
