Information contained within this document is supplementary to the initial application for a review dated 01/03/2022 and in addition to the first supplementary information submission dated 29/03/2022.

Further supplementary incidents of note:

On 7th May 2022:

Approximately 0330: Council CCTV report an unresponsive male outside of the shop with a group of his associates attempting to rouse him. Baba Food and Wine staff are seen to be aware of the group. At 0527 hours Southeast Kent Ambulance service attended to ascertain that the male was very intoxicated.

Approximately 0445, an intoxicated female alleged that the males in the group were fighting with her and made comments of self-harm.

Kent Police produce council and premises CCTV evidence of numerous alcohol purchases, linked to these two incidents between 0248 and 0500.

On Wednesday 11th May 2022:

Approximately 0254 a vulnerable male reported being robbed on the junction of High Street and Canterbury Street. Council CCTV shows the male being punched and kicked on the floor. The two suspects are then seen to leave the location. Kent Police produce council and premises CCTV of alcohol purchases from the premises by the offender.

Also included in this supplementary information submission are two statements from local residents who evidence recent nuisance, rowdy behaviour and drinking on Gillingham High Street by drivers having purchased alcohol from the venue.

These two statements have been redacted of all personal details as neither witness wish to be identified for fear of reprisals.

I have recently moved into a premises in close proximity to a shop on Gillingham High Street called Baba Food and Wine.

I very much regret moving into this area due to what I now realised is a problem for me and my preschool age son.

During my time in my new address, I have often become aware of very loud music coming from cars parked outside of Baba food and Wine. The drivers mostly seem to be males with tanned skin, of an eastern European appearance. I watch how they enter the shop and come out with bags of alcohol. They then seem to have loud parties outside of Babas and regularly drink the alcohol which they had just bought. They also don't care about any residents as they then see the need to shout at one another. They hang around for some reason, sometimes until the early hours of the morning. This behaviour is not limited to weekends only as this occurs during the week too.

I am upset at the situation as the noise often wakes my son up. I am sometimes able to comfort him so that he falls asleep again quickly, but often he becomes distraught at all the disruption. I am sure that not only myself but that other residents in this area are also annoyed about what is going on outside of Babas Food and Wine and are as afraid as me to say anything about it.

I have lived on Gillingham High Street for about 18 years. I live in the proximity of a shop called Baba Food & Wine. This past weekend on Sunday 8th May I was at home approximately 2:00 hours. Outside of Baba Food and Wine and up the road there were about 20 cars. Everyone was being loud, drinking and smoking with their music up very loud. They were racing up and down the high street causing tyre marks and being a nuisance. These people in their cars are all there as Baba Food and Wine is open and selling alcohol. I watched many of them as I always go into the shop and come out with alcohol. Then then

started drinking it which being very loud outside. It is a constant issue. These vehicles and their owners are a constant problem with my neighbors and friends who live nearby. Although Sunday the 8th May 22 was particularly bad, there are always similar issues outside of this shop; especially on a Friday, Saturday and Sunday nights. ^{There} are people outside of that shop at all hours of the night and early hours of the morning, sometimes until 6 or seven in the morning. I watch them enter Babar, then come out with alcohol and drink it outside. It used to be bad a couple of years ago, but it is getting worse.

The shop attracts alcoholics who then sit outside the shop and the church who then drink it in ^{front} public. It looks disgusting. No one should have
