## Details of supplementary information:

Information contained within this document is supplementary to the initial application for a review dated 01/03/2022 and in addition to the first supplementary information submission dated 29/03/2022.

Further supplementary incidents of note:

#### On 7th May 2022:

Approximately 0330: Council CCTV report an unresponsive male outside of the shop with a group of his associates attempting to rouse him. Baba Food and Wine staff are seen to be aware of the group. At 0527 hours Southeast Kent Ambulance service attended to ascertain that the male was very intoxicated.

Approximately 0445, an intoxicated female alleged that the males in the group were fighting with her and made comments of self-harm.

Kent Police produce council and premises CCTV evidence of numerous alcohol purchases, linked to these two incidents between 0248 and 0500.

#### On Wednesday 11th May 2022:

Approximately 0254 a vulnerable male reported being robbed on the junction of High Street and Canterbury Street. Council CCTV shows the male being punched and kicked on the floor. The two suspects are then seen to leave the location. Kent Police produce council and premises CCTV of alcohol purchases from the premises by the offender.

Also included in this supplementary information submission are two statements from local residents who evidence recent nuisance, rowdy behaviour and drinking on Gillingham High Street by drivers having purchased alcohol from the venue.

These two statements have been redacted of all personal details as neither witness wish to be identified for fear of reprisals.
