Summary

- 1. Budget and policy framework
- 1.1 Under Chapter 4, Part 5 of the Constitution Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny Committee has the responsibility for setting its own work programme.
- 2. Background
- 2.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.
- 3. Agenda planning meeting
- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 19 May 2022.
- 3.2 At the meeting, Members were informed that the Regional Schools Commissioner was unable to attend the May meeting of the Committee and therefore the annual of the School Performance Report will be taken and an alternative date sought for the Regional Schools Commissioner to attend Scrutiny.
- 3.3 At the meeting Members also requested that activity relating to briefing note requests be provided to enable the Committee to keep under review

outstanding requests and recent publications. A section providing the latest position on briefing notes is set out in section 7 of this report.

Title: Gateway 1 Procurement Commencement - Family Time (Contact Service) for Children in Care and their Families Contract

Description: This report will seek Cabinet approval to commence the procurement of the Family Time (Contact Service) for Children in Care and their Families Contract.

Anticipated Cabinet Decision Date: 26 Jul 2022

Title: Gateway 1 Procurement Commencement - Supported Accommodation and Floating Support Contract

Description: This report will seek Cabinet approval to commence the procurement of the supported accommodation and floating support services for Medway's Looked After Children and Care Leavers Contract.

Anticipated Cabinet Decision Date: 26 Jul 2022

Title: Proposals to Change Three Grammar Schools from Single Gender to Co-Educational Provisions - Outcome of Consultation

Description: The report will present the outcome of a public consultation in relation to potential for increasing co-educational grammar places in Medway and will ask the Cabinet to agree the next steps. The report will, initially, be considered by the Children and Young People Overview and Scrutiny Committee on 28 July 2022.

Anticipated Cabinet Decision Date: 23 August 2022

Title: Joint SEND Strategy

Description: This report will request Cabinet approval of the Joint SEND (Special Educational Needs and Disabilities) Strategy.

The Strategy will initially be considered by the Children and Young People Overview and Scrutiny Committee on 29 September 2022.

Anticipated Cabinet Decision Date: 18 Oct 2022

5. Performance Data Workshops

- 5.1 At the Committee's meeting on 5 March 2020, it agreed a number of measures to maximise its involvement and impact in relation to the scrutiny of children's social care.
- 5.2 Part of those measures included the provision of detailed performance data to all members of the Committee on a monthly basis and for performance data workshops to be provided, in between Committees. The purpose of this is to strengthen the capacity for effective scrutiny of performance by providing an informal setting in which detailed analysis of the data can be undertaken. Members can then apply their increased knowledge and understanding to carry out an effective scrutinising role in main committee meetings and in task group activity.
- 5.3 The latest workshop was held virtually on 23 June 2022. This session was attended by the Assistant Director, Children's Social Care
- 5.4 The workshop focused on shaping future sessions to ensure that they were meaningful and continued to be effective. Members agreed that the workshops held to date had been useful in development of their knowledge and skills. This had enabled them to improve their ability to hold to account the senior leadership team as appropriate and drive forward in-depth scrutiny at meetings.
- 5.5 It was agreed that going forward, the Assistant Director, Children's Social care and the Democratic Services Officer would work together to identify through topics from Committee meetings, themes for future workshops. A programme of themes for data workshops would be discussed at pre-agenda meetings and agreed at each Committee meeting.
- 5.6 The next workshop will take place on Thursday 10 August 2022 and the theme for the session will be on recruitment and workforce development.

6. LGA Training

6.1 The Committee took part in its first session of a Local Government Association (LGA) pilot to support political and corporate leadership for children's services on Monday 25 April 2022. The theme of the session was on the effective steps to scrutiny, with discussions on member role, barriers to

effective scrutiny, work programming, undertaking reviews and evidencing the impact of the work of the committee. Attendees had the opportunity to share ideas and brainstorm on how to take forward the ideas discussed to implement and drive change.

The final session of the pilot will take place on 17 August 2022.

8. Implications for looked after children

- 8.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for looked after children and have the same high expectations of them as they would for their own child, grandchild or niece/ nephew.
