Summary

- Budget and Policy Framework
- 1.1 Each Overview and Scrutiny Committee has the responsibility for setting its own work programme (Chapter 4 Rules, paragraph 21.1 (xv) General terms of reference).
- 2. Background
- 2.1 The Committee's work programme for the remainder of 2022/23 municipal year is attached at Appendix 1. One of the Committee's functions is to provide guidance and leadership on the development and co-ordination of the scrutiny function for all Overview and Scrutiny Committees. Appendix 2 sets out the work programmes for the other Overview and Scrutiny Committees.
- 3. Agenda Planning Meeting
- 3.1 Members will be aware that overview and scrutiny committees hold agenda planning meetings on a regular basis. These give officers guidance on information Members wish them to provide when scrutinising an issue. An agenda planning meeting took place on 5 January attended by the Chairman, Vice-Chairman and Opposition Spokesperson.
- 3.2 At the meeting, it was advised that the review of the Council's risk strategy and risk plan was ongoing and would not be considered by the Audit Committee until its meeting on 16 March. It had therefore been necessary to amend the BSO&S work programme to move it from this meeting to 30 March. It would then be considered by Cabinet on 4 April.

3.3 There was a discussion about the Committee's work programme for 2023/24 and it was suggested that the structure and content of the work programme be considered at the next agenda planning meeting and reported to the Committee on 30 March for consideration. This would include a review of the items currently listed under 'Date to be Determined' as well as any outstanding actions and would serve as a handover report to the new Committee.
