1 Summary description of the proposed change
<p>Arches Chatham Neighbourhood Forum has prepared a draft Neighbourhood Plan for its neighbourhood area and submitted it to Medway Council to progress the process of bringing the plan to adoption. Medway Council is required to publish the draft Neighbourhood Plan for consultation.</p> <p>Once adopted, or 'made', it will form part of the development plan for the area, alongside the Medway Local Plan, and will be used in determining planning applications.</p> <p>The draft Neighbourhood Plan sets out policies for the sustainable growth of the Neighbourhood Area of Arches Chatham, which covers parts of Luton and central Chatham. It includes policies for housing, built and natural environment, sustainable transport, local economy, community spaces, as well as setting out a number of site allocations.</p> <p>The policies guide decisions on future development. The Neighbourhood Plan will apply to the defined Arches Chatham Neighbourhood Area.</p>
2 Summary of evidence used to support this assessment
<p>The draft Plan considers the demographic profile of the neighbourhood, made up of over 8000 people enriched in a diversity of cultural and generational backgrounds. It notes issues of high levels of deprivation.</p> <p>The Neighbourhood Planning Forum carried out consultation and engagement with all sectors of the local community throughout the preparation of the draft plan in recent years. The policies seek to provide for sustainable development in the neighbourhood, supporting local communities and enhancing the area's built and natural environment. These include environmental improvements to air quality and amenity, and housing to meet the needs of local residents. The policies and the Neighbourhood Plan are intended to provide the benefits of sustainable development for all residents. Given the scope of the Neighbourhood Plan, it is difficult to define impacts on specific groups in the community, as the policies will apply to the whole neighbourhood area in relation to development proposals.</p>

4 Summary of the likely impacts

The draft Neighbourhood Plan promotes sustainable development in the Arches Chatham neighbourhood. It aims to promote social and economic well-being for residents, and enhance the environment. All residents are potentially affected. The housing policies seek to provide for a range of local needs, including for families and people on low incomes. The draft plan seeks to secure community facilities that can benefit a range of local residents, particularly those who are less mobile, and which support specific cultural and religious communities. Policies that seek to improve urban greening and air quality will benefit the wider community. The policies on public realm and provision of sports facilities and play spaces recognise the needs of people with disabilities.
