I am currently employed by Kent police and work as a licensing officer. Within the team of four police licensing officers, we cover the North Division area which includes the Medway district. On Friday 3<sup>rd</sup> March 2023, approximately 2015 hours, I attended Jollof Lounge, 44 High Street, Chatham with Helen Buddin, a licensing officer of the Medway & Gravesham council shared licensing team, to conduct a licencing visit at the premises and in particular to confirm if the premises were complying with condition 18 of the premises licence which states:On Friday/Saturday/Christmas Eve/ New Year's Eve and bank holidays, there will be a minimum of 2 SIA door supervisors on duty from 20:00 until closure of the premises and all members of the public have left. For any other event, the designated premises supervisor will complete a written risk assessment in respect of the provision of door supervisors. If deemed necessary, a minimum of 2 SIA registered door supervisors will be employed at the premises."
On approaching the premises, I saw one male stood outside, who was dressed in dark clothing

and was displaying a Security Industry Authority licence on his arm. On speaking with this male, he stated he worked at the premises every Friday however he worked at the premises on his own. After checking the SIA licence was all in order, we left this male outside and went into the premises.

After identifying ourselves to a staff member who then disappeared from view, a manager, Ariike Fadeyi came out of the rear of the premises. When asked where the other SIA door supervisor was,

she stated that he was running late and then started using her mobile phone to contact the other SIA door supervisor, however could not provide a time when he would arrive. While I was within the premises, Kingsley Atuanya, the designated premises supervisor and director of the premises licence holder arrived and he was aware of the issue regarding only one SIA door supervisor being present. After speaking with him for a short time, I left the premises however the second SIA door supervisor was still not present.

In order to ascertain if the second SIA door supervisor had arrived at the premises to comply with the premises licence, I returned alone to Jollof Lounge approximately 2330 hours on 3<sup>rd</sup> March 2023.

I saw the first SIA door supervisor still outside, as he was on my first visit and on entering the premises, I recognised Ariike Fadeyi and asked her if the second SIA door supervisor was present. She told me she would get him and shortly afterwards, a second male came from the rear of the premises, wearing dark clothing and displaying an SIA licence on his arm. After checking his SIA licence was all in order, I asked him why he had been late and he replied that his wife had given birth to twins earlier in the day. I asked him why he was at the premises rather than being with his wife, he stated he needed to earn money, so was working at the premises.

I then left with both SIA door supervisors present at the premises.
