Summary

This report advises Members of the current work programme for discussion in the light of latest priorities, issues and circumstances, giving Members the opportunity to shape and direct the Committee's activities.

- 1. Budget and policy framework
- 1.1 Under Chapter 4 Rules, Part 4 paragraph 21.1 (xv) General Terms of Reference, each Overview and Scrutiny Committee has the responsibility for setting its own work programme.
- 2. Background
- 2.1 Appendix 1 to this report sets out the Committee's proposed work programme.
- 3. Agenda planning meeting
- 3.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. An agenda planning meeting was held on 31 May attended by Councillor McDonald (Chairman), Councillor Shokar (Vice-Chairman) and Councillors Wildey and Crozer (Opposition Spokespersons). The meeting was also attended on this occasion by Councillor Murray, Deputy Leader. Councillor Murray advised that as well as the usual annual report where she is held to account by this Committee, she was also willing to be held to account on a more regular basis, where appropriate. Councillor Murray also outlined her priorities as Deputy Leader as they relate to this Committee:
 - Reducing health inequalities
 - Mental health services

- Women's health services
- The GP Access Task Group report (a suggestion was made that an update on this matter comes to the August meeting, following consideration by Cabinet of this report in June)
- The eating disorder service
- Tackling deficits in adult social care funding
- Looking at different ways of providing services
- Drugs partnership and addiction work
- 3.2 Councillor Murray also suggested that an event be organised with key health partners so that Members, particularly new councillors, can gain a better understanding of how the Council works and interacts with partners.
- 3.3 At the agenda planning meeting, Members recommended the following changes to the work programme:
 - Substance Misuse Services (*move to August and invite new provider to attend*)
 - Deprivation of Liberty Safeguards (DOLS) to Liberty Protection Safeguards (move to unallocated as the Government has indicated these changes will not be implemented until after the next General Election, but briefing note to be provided on how many people in Medway are subject to these arrangements)
 - Community Health Services (propose add to August)
 - Medway NHS Foundation Trust Quality Account 2022/23 (propose add to June)
 - Add an update from the Kent and Medway NHS Social Care and Partnership Trust (KMPT) to the August agenda.
- 3.4 At its last meeting, the Committee agreed to review the last four years, including the structure and content of the work programme, an update on Task Groups and any outstanding matters and actions, to serve as a handover document to the new Committee after the elections. This is set out in Appendix 2.
- 4. Cabinet Forward Plan
- 4.1 The latest Forward Plan of forthcoming Cabinet decisions was published on 15 May. The following items listed on the forward plan relate to the terms of reference of this Committee. The Committee is asked to identify any items it may wish to consider as pre-decision scrutiny (where dates permit).
