Summary

This item advises Members of the current work programme and allows the Committee to adjust it in the light of latest priorities, issues, and circumstances. It gives Members the opportunity to shape and direct the Committee's activities over the year.

1. Recommendations

2. Budget and policy framework

Under Chapter 4, Part 5 of the Constitution – Overview and Scrutiny Rules, paragraph 21.1 (xv) General terms of reference, each overview and scrutiny Committee has the responsibility for setting its own work programme.

3. Background

3.1 Appendix 1 to this report sets out the proposed work programme for the Committee during the current municipal year.

4. Agenda planning meeting

4.1 Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information that Members wish them to provide when scrutinising an issue. An agenda planning meeting was held on14 September 2023 with the Chairperson and Opposition Spokespersons.

4.2 At the meeting, Members suggested the following:

- 4.2.1 The meeting on 5 December 2023 would be finance themed and a data workshop session would take place ahead of that meeting, date of which is to be confirmed. One of the objectives would be to provide members with an understanding on how funding is spent, the direction of travel of the service and how this links in financially with the long term aspiration and plan.
- 4.2.2 Following discussion, it was agreed that the Annual Schools Performance report be presented to the Committee at its meeting of 11 January 2024 with the data (unvalidated) available. A data workshop session will take place prior to the formal meeting. The Annual Schools Performance report (validated data) will then be circulated to Members virtually in March. This action is proposed going forward as taking the report at an earlier time in the meeting cycle will prevent instances whereby the Committee receive data that is lagged.

6. Performance Data Workshops

- 6.1 At the Committee's meeting on 5 March 2020, it was agreed a number of measures to maximise its involvement and impact in relation to the scrutiny of children's social care.
- 6.2 Part of those measures included the provision of detailed performance data to all members of the Committee on a monthly basis and for performance data workshops to be provided, in between Committees. The purpose of this is to strengthen the capacity for effective scrutiny of performance by providing an informal setting in which detailed analysis of the data can be undertaken. Members can then apply their increased knowledge and understanding to carry out an effective scrutinising role in main committee meetings and in task group activity.
- 6.3 The next workshop will take place 3 October 2023 at 5:00pm via Microsoft Teams and the session will be on Children's Social Care.

7. Scrutiny Task Groups

- 7.1 The Council has agreed that up to three in-depth scrutiny Task Groups or themed Overview and Scrutiny Committee meetings can be supported in total across all four of the Council's Overview and Scrutiny Committees every year, with each review running successively. A process for determining the programme of Task Group themes and activity has been agreed, with the Business Support Overview and Scrutiny Committee having a co-ordinating role. Topics are prioritised on a criteria selection basis reflecting best practice.
- 7.2 At the Children and Young People Overview and Scrutiny Committee meeting pre-agenda meeting of 14 September 2023, following consultation with groups, it was decided that the Committee would put forward Education Inequality and Child Mental Health as its suggested topics
- 7.3 A meeting of Overview and Scrutiny Chairpersons, Vice-Chairpersons and Spokespersons will take place on 4 October 2023 to discuss the topics put forward and shortlist four topics and their priority order to be recommended to Business Support and Digital Overview and Scrutiny Committee for a final decision.
- 8. Implications for looked after children
- 8.1 Members should ensure they focus on outcomes for looked after children. This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that looked after children can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for looked after children and have the same high expectations of them as they would for their own child, grandchild, or niece/ nephew.
