- 4.1 Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. These give officers guidance on information Members wish them to provide when scrutinising an issue. An agenda planning meeting was held on 12 October 2023.

- 4.2 At the agenda planning meeting it was noted that January would be too early to present an update on Safer, Healthier Streets Proposed 11 School Streets as there would not be enough available data so it was agreed to move this to date to be determined on the Work Programme.
- 4.3 Members were also informed that the Community Safety Plan 2024 2028 has been added to the Work Programme for 26 March 2024.
