There are already a lot of pubs in the area and we get a lot of drunks shouting and fighting in the streets

The entrance to my flat is down a side ally and people wander down to relieve themselves in our car park. We have also had people selling and smoking drugs outside our building.

I am worried about what will happen if there are more people drinking until the early hours of the morning. My neighbour has young children and this behaviour is unsafe for them.

The Restaurant plays it's music very loud and this is not fair on their neighbours. I am autistic and have sensory disorders. I find the loud music really upsetting and this stops me from living my life the way I would want to.

The restaurant is small and is not soundproofed. The music they play is way louder than it needs to be.

We previously had problems with a pub over the road called the Northern Seaman at 378 High Street. They did not have soundproofing either and their live music caused a lot of disturbance.

I am not against live music but it needs to be appropriate for the venue and end at a reasonable time.

Protection of children from harm

My neighbour has young children and it is not healthy for them to have loud music playing so late at night

Also, due to the problems we've had with drunk members of the public defecating and dealing drugs in the alley beside and the car park behind the property, it's concerning that this could increase.

Please suggest any conditions that you think could be added to the licence to remedy your representations or other suggestions you would like the Licensing Sub Committee to take into account

Music should be quieter or there should be soundproofing.

Late night drinking would be harmful for local residents and this should not be encouraged. There are already enough pubs and clubs on this part of the high-street and nuisance drinking is already a problem.

The business needs to be more mindful of local residents, especially people with children and disability needs
