

TITLE: Parking Charges at Country Parks

DATE: 13th February 2024

1. Summary description of the proposed change

What is the change to policy / service / new project that is being proposed? How does it compare with the current situation?

It is proposed to implement a charging regime for visitor parking at Medway's Country Parks. A charge of £2.50 per day for vehicles and £9 per day for coaches would apply to Riverside Country Park, Capstone Country Park and, subject to planning permission, any new country park coming forward at Deangate Ridge. An annual season ticket priced at £60 would be available for visitors to purchase. Payment for parking would be made via Pay & Display machines (card and cash) and RingGo, with season tickets purchased via the Council's website. Blue Badge holders, motorcycles, Council staff based at Deangate Ridge and users of Deangate Ridge indoor bowls club would be exempt from the parking charges.

These new fees, if agreed, would generate income, which the Council could use to assist with budget pressures by allocating any surplus to highway and environmental improvements, and off-street parking infrastructure.

2. Summary of evidence used to support this assessment.

An assessment of the feasibility and viability of introducing parking charges has been undertaken, supported by a detailed financial and operational strategy for charging implementation and risk mitigation. Due consideration has been given to ensuring regulatory compliance, for example with Section 55 of the Road Traffic Regulation Act 1984, as amended. Data indicates that Capstone and Riverside Country Parks generate, on average, 31,400 vehicle movements per month.

The proposed charges have been benchmarked against the charges for parking in Country Parks levied by Kent County Council and the charges levied for town centre parking by Medway Council. Existing charges for parking at Country Parks operated by Kent County Council range between £1.50 per day and £3.00 per day Monday to Fridays and between £2.00 and £4.00 per day at weekends and Bank Holidays.

An informal consultation process has not been undertaken. Prior to implementation, a Traffic Regulation Order (TRO) would need to be produced and would be subject to a statutory consultation period of 21 days for respondents to consider and provide feedback.

The following actions have been identified to mitigate against the adverse impact for low-income groups:



- Blue badge holders are exempt from payment (when displaying a valid badge), motorcycles and cycles are also exempt.
- A parking season ticket will be available for purchase, which will offer parking at a reduced cost per day for frequent visitors.
- Appropriate communications in advance of implementation will ensure appropriate lead-in time for visitors to prepare to pay for parking.
- Signage will be clear and consistent across all parks, aligning with statutory guidance.
- The Council will actively promote alternative forms of transport, carsharing and active travel for visitors to our Country Parks. This will include identifying opportunities for improving access by bus, which would be of particular benefit to those in receipt of Concessionary Travel.
- The new charge will be reviewed on an annual basis to make sure it is appropriate and consistent with the facilities provided and other Country Parks in neighbouring authorities.
- Surplus funding could be used to ensure good standards of maintenance and improved facilities at the Council's Country Parks, which would benefit all users.
- The Council will promote public open spaces and other recreational facilities that can be accessed by car without a requirement to pay for parking.
