Appendix 1 – Contract performance

1. Background

- 1.1. This appendix report seeks to review the performance of the Household Waste Recycling Centre (HWRC) Contract delivered by Medway Norse.
- 1.2. The review period is September 2017 until September 2024. Any data for the period April to September 2024 is a forecast.

2. Contract management

- 2.1. Overall responsibility for this contract falls under the Head of Regulatory and Environmental Services' remit. Contract management is the responsibility of the Waste Disposal Manager.

- 6. Summary of contract performance 2017-2024
- 6.1. The delivery of this contract supports the Council in meeting its statutory duties to provide HWRC services which persons resident in the area may deposit their household waste (Environmental Protection Act 1990).
- 6.2. The monitoring of contract performance is managed through regular meetings alongside auditing of the HWRC sites, data provision and disposal points. This supports the Council in meeting its statutory duties under the Environmental Protection Act 1990 to ensure waste is collected, stored, treated and disposed of properly.
- 6.3. Table 2 below presents a forecast indicating that 137.8K tonnes of waste will be processed throughout HWRC contract term.
