They are already making there way down this end of the high street after removal of benches. One other neighbour is also known to associate with these people not the one with offences. It will be being the alcohol to people that already cause issues as it is so this will just encourage problems.

These are my findings why I object for 18, Arden Street applying for a 24hr drinking licence.

These people care about making money not thinking about the welfare of the residents on our streets. My daughter suffers from anxiety which she has seen fights outside our house, the cab station window smashed and Police knocking on our door in the early hours of the morning as we have CCTV. Although we have seen constant trouble outside our house the trouble at the Monarch Pub ended 11pm when the pub shut.

By giving a 24hr alcohol licence to 18 Arden Street this will attract drunken dossers which will cause anti social behaviour in the area. Bottles and windows smashed and noise which will keep residents awake and frightened. Also shoplifters will cause a big problem when confronted by the owners of 18 Arden Street. Police will be called and nothing will be done as the cost of theft is not over the value of £100 pounds.

Smashed bottles left on the floor unattended would harm young children and old age people walking by. Council sweepers are not often around to clean up which means I would have to do it. Police are under funded and this will cause a waste of tax payers money. Some months ago, I spoke personally to Naushabah Khan the labour MP for Gillingham concerning BaBa 24hr off licence on the high street. Going to work in the early hours of the morning, down and outs, tramps, winos are smashing bottles fighting and intimidating people walking by. I have even seen a drunken young man smash a bottle over another young man's head. I can't understand why can't they have a licence up to 11pm instead of 24 hours.

The thing about BaBa 24hr Off licence there are no houses around that shop only high rise flats.

But us CNC cab station Number 14 and 16 will have to live with this profiteering nightmare.

Also this will cause my property in the future having trouble selling due to this 24hr drunken binge.

My grand children come over at the weekend which trouble will cause a devastated impact on there mental health. Police will be attending a number of times which will be a waste of tax payers money.

My wife suffers from depression since I bought this place in 2020 she take amitriptyline tablets to calm her self down. This 24hr off licence will cause her more problems to her health, the early hours of the morning would mean no traffic wardens, drivers parking on double yellow lines out side my property blaring their music, talking loudly while beebing their car horns while entering the off licence. There is an alley way on the back of our house where small crowds drink and talk loud which wakes the residents in the area. By having this off licence will encourage more people to congregate and make a nuisance of them selves. If customers went to the off licence and bought goods and went home that would be fine. But that is not the case, most Saturday nights, fights on Fox Street are frequently happening due to male and female intoxicated by alcohol from Baba.

If 18 Arden Street gets this licence it will cause mentally and personal break up towards me and my family. I would have to place incidents in a diary take pictures and film Criminal activities to prove I was right, but I would be mentally drained for proving I was right from the

start. The NHS are at breaking point at the moment, there will be more drunken patients injured and admitted due to there self inflicted pain. The consequence of having a 24 hrs off licence has a long chain of waste of time and money wasted through the emergency services. Old and sick need the NHS more then self inflicted anti sociable binge drinkers. Who decided a 24hr off licence which only effects liver failure to human health. What happened to the days when alcohol was stopped at a certain time. I now have the motivation to get a petition together and write to my MP Naushabah Khan and ask her to put forward in The House of Parliament a new legislation to stop 24hr drinking licence. The Police do a great job in protecting the community it would be a shame for them to have to deal with drunken yobs then dealing with more serious crimes.
