6. Performance Data Workshops

6.1 At the Committee's meeting on 5 March 2020, it was agreed for a number of measures to be put in place to maximise involvement and impact in relation to the scrutiny of children's social care.

This includes considering their physical health; their emotional health; their safeguarding; their educational attainment and progress; their hopes and aspirations for their adult lives and how looked after young people have their voices heard. We know that children in care can be more vulnerable to sexual exploitation so particular attention should be given to this. As a corporate parent, Members should be a champion for children in care and have the same high expectations of them as they would for their own child, grandchild, or niece/ nephew.
