- 4. Agenda planning meeting
- 4.1. Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. The agenda planning meeting that was held on 24 July 2025 attended by Councillor McDonald (Chairperson), Councillor Campbell (Vice-Chairperson) and Councillors Crozer, Finch and Wildey (Opposition Spokespersons).

- 4.2. The following changes to the work programme were recommended:
 - A report on All Age Mental Health Services was added to the August meeting.
 - An update to the Committee on Community Services was recommended for addition to October meeting, with an offer for an informal briefing in the interim, this will take place on Wednesday 3 September 2025 at 6pm, via MS Teams.
 - Reference was made to a recent issue identified by Medway NHS
 Foundation Trust that almost 9000 referrals into the Ear Nose and Throat
 clinic had not been managed correctly. An investigation, commissioned
 by NHS England was ongoing and this would be reported to the
 Committee at its October meeting as the investigation would not be
 concluded by the August meeting.
 - The Deputy Leader to be scheduled to be held to account at the October meeting.
 - The Annual report of Adult Social Care Complaints and Compliments to be scheduled for the October meeting.
 - The draft report of the Air Quality, Public Transport and Active Travel Task Group be scheduled for the October meeting.
 - The Director of Public Health's Annual Report be scheduled for the December meeting.
 - An update on the progress against the CQC Action Plan be scheduled for January meeting.
 - An update on the Integrated Care Strategy be scheduled for the January meeting.
- 4.3. Following the agenda planning meeting, please note that the Council Plan Performance Monitoring/Strategic Risk Summary Quarter 1 report has been rescheduled for the October meeting, it had inadvertently been listed for the August meeting.
