- 4.1. Members will be aware that Overview and Scrutiny Committees hold agenda planning meetings on a regular basis. An agenda planning meeting was held on 8 December 2025 and was attended by Councillor McDonald (Chairperson), Councillor Campbell (Vice-Chairperson), Councillor Crozer, Councillor Finch and Councillor Wildey (Opposition Spokespersons).

- The report on the Early Help Offer and carers was deferred to the March meeting of the Committee.
- The report on the progress against the CQC Action Plan was deferred to March and will be combined with the Improvement Plan Progress update already scheduled for the March meeting.
- The report scheduled for January to provide an update on progress against the Integrated Care Strategy was removed from the work programme and officers were instead asked to explore providing the update via a development session instead.
