

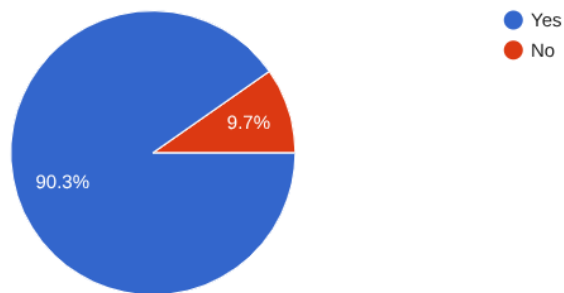

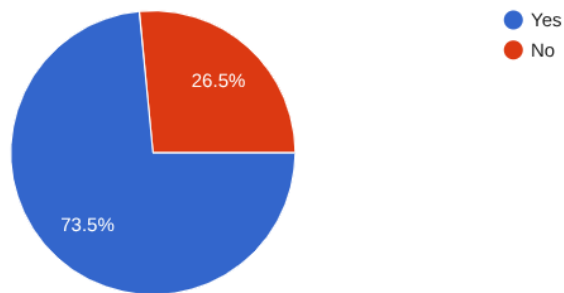


Door Signs

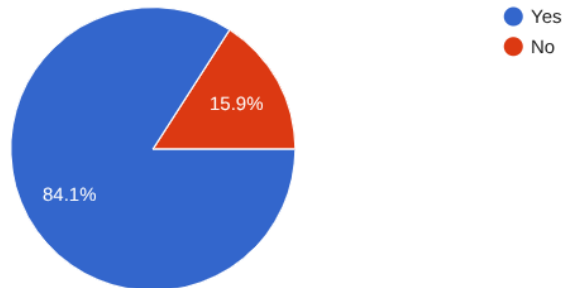


Penalty Points for speeding

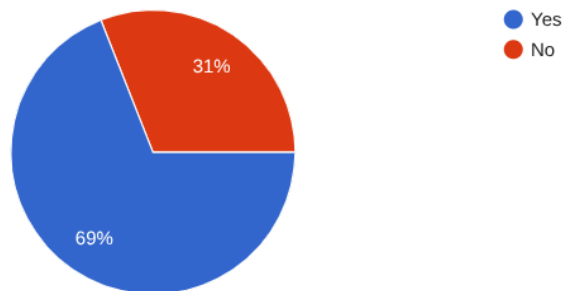


PH vehicle colour

Driver Comments

The age limit of vehicles is unfortunately necessary, there's too many old tired grubby looking vehicles on ranks that leave a poor impression of the taxi trade in Medway, I've actually had customers tell me they've used Uber because they're always clean and newer model cars. Maybe a compromise could be used ie a maximum number of years licensed after original license being issued say of twelve years or a maximum mileage say 250,000 miles as an example.

Vehicle age should have no bearing on usability as long as it is roadworthy and in good condition. Door signs on PH should be retained to avoid any confusion amongst customers and fellow drivers. DVLA rules on licenses is 12 points, reducing to 6 is undermining long standing government rules and it is very easy to get 6 points, then the driver will lose their livelihood Should retain red PH again to avoid confusion.

Door signs should remain on at all times .

Exempted only on school run or long distance.

Vehicle age should never have been put in place. We currently mot our vehicles twice a year and if it is road legal then there is no reason for it not to be driven as a taxi.

Proposed Amendments to Vehicle Licensing and Operational Requirements

Proposed Amendments to Vehicle Licensing and Operational Requirements

1. Vehicle Age Limit

Since 2021, all newly licensed vehicles have been subject to age restrictions of 10 years for non-wheelchair accessible vehicles (non-WAV) and 15 years for wheelchair accessible vehicles (WAV). It is proposed that these age limits be removed.

Vehicle condition, safety, and roadworthiness are already monitored through regular MOT testing and licensing inspections. Removing the fixed age limit would allow well-maintained vehicles to remain in service while still ensuring safety and compliance.

2. Penalty Points for Speeding Offences

Under current policy, drivers who accumulate more than two SP30 speeding offences, resulting in six penalty points on their DVLA licence, may face licence suspension or revocation.

It is proposed that this threshold be increased to 9 or 12 penalty points before any suspension or revocation is considered. This would bring greater proportionality to enforcement while still maintaining road safety standards.

3. Door Signage Requirements

At present, private hire vehicles are required to display door signage identifying the operating company. However, all Medway-licensed private hire operators now use digital booking and dispatch systems. These systems provide passengers with full vehicle and driver details at the point of booking. Given this, it is proposed that the requirement for door signage be removed, as it no longer serves a necessary public safety or identification purpose.

4. Private Hire Vehicle Colour Requirements

Department for Transport guidance states that Hackney Carriage vehicles must be clearly identifiable to the public, as they are permitted to ply for hire. In Medway, this requirement is met through the standard white vehicle colour and official taxi livery.

The same guidance also states that private hire vehicles should not resemble Hackney Carriages, as they must be pre-booked. In light of this, it is proposed that the current requirement for private hire vehicles to be red should be removed. Allowing a wider choice of colours, excluding white, would maintain clear distinction while providing greater flexibility for operators.

All the taxi company's in medway are computer rise know working with the PDA not call out system with the CB radio anymore. Soon as driver accept the job passengers got the information on their phone. Drivers car s Taxi registration number driver's name and what time he's arriving to pick them up. You don't need to have door signs on maybe on a private hire hire cars, not on heckney, because you got a Big Top sign on the roof. The other reason most the new hybrid electric cars. Got aluminium, body.and doors you can't stick magnetic door signs. You have to use stronger glue or double side cellotape. Which damage the paintwork.

We have so much stress in our daily life. So everyone is prone to do mistakes when driving all day for a living. Nobody is perfect. I've known in the past people from the police forces having 9 points on their license. I think that if you decrease the points on the license before you suspend it revoke it that you will put us through immense pressure driving. Therefore I think that this is unacceptable.

The age of the car should be tested at 10years. As some cars are 10years, however are better looked after and maintained than other licensed taxis.

Understandable that HC should be white, however it shouldn't matter for private hire.

My main concern is about the penalty point. Taxi drivers are very hard working people. We serve the community 24/7. All of us have families, mortgage, kids to look after and this is the only job most us have. We always try our best to look after our customer and also protect our job and license. It would not be fair if I or other taxi drivers lose their license over couple of points.

Vehicle age limit shouldn't apply at all to wheelchair accessible vehicles as they're very expensive

Should have all new cars

If door signs go then the private hire colour should remain red. Customers recognise white and red as licensed vehicles which makes it harder for "bad" people to go out in any car preying on the vulnerable

The current 10-year vehicle age limit for taxi drivers is unfair and unrealistic. Vehicles have become extremely expensive, while taxi work is no longer as profitable as it used to be. Many drivers are struggling to survive in the industry, and forcing them to replace vehicles so frequently places an unnecessary financial burden on them. There should either be no vehicle age limit, or it should be extended to at least 20 years, provided the vehicle passes all safety and roadworthiness inspections.

Secondly, the requirement for company door signs is unnecessary, especially for drivers who work independently. Displaying company branding does not serve any meaningful purpose in such cases and often results in damage to vehicle doors, reducing the car's value and causing additional repair costs. This requirement should be reconsidered or made optional.

Finally, regarding driving offences, minor speeding offences should not result in such harsh penalties. If a driver has no serious driving offences, the threshold for suspension of a taxi licence should be at least 12 penalty points, in line with fairness and proportionality. Taxi drivers rely on their licences for their livelihood, and minor infractions should not put their entire career at risk.
