- No sales of spirits shall be made in containers of less than 200ml in volume

Also, are the opening times of the store different to the licenced hours? If so, I would consider a need to have shutters or blinds over the alcohol fridges etc to make it clear the alcohol is not for sale. If the opening times mirror the licenced hours, this wouldn't be needed.

If those two areas are clarified and covered, I can confirm we would be able to withdraw our reps and withdraw from the hearing process.

I can confirm that we will be reducing this application to the following hours:

Monday to Saturday: 08:00 to 20:00

Sunday: 10:00 to 18:00

This is in line with the correspondence our client submitted in support of his application.

Also, I need to make you aware that as part of this process we would intend to request a change to a condition that is already on this licence as follows:

Spirits and wine are to be displayed behind the counter

You will be aware that the condition is meant only to ensure that spirits are kept behind the counter and the inclusion of wine in this condition was an error made by whoever formulated this licence. Wine is never stocked behind a counter, and of course white wine should be in the fridge!

Our client brought this to my attention and although it didn't form part of his application, I said I would address it as this variation allows alteration to conditions and so there is no reason that this condition cannot also be amended as part of this process. I will be asking for the committee to change this condition at the hearing to "Spirits will be displayed behind the counter", but as the police and Public Health have not yet been made aware it is important that we get their approval for this change in advance.

Would it be possible for you to send this email to them and ask them to respond to this change as it will be important to the committee that they know the authorities view on this point.
