### EXCLUSION OF PRESS AND PUBLIC

#### Summary

This report summarises the content of the report and appendices which, in the opinion of the proper officer, contain exempt information within one of the categories in Schedule 12A of the Local Government Act 1972. It is a matter for the Cabinet to determine whether the press and public should be excluded from the meeting during consideration these documents.

#### 1. Recommendation
